# American University's Annual Latino Public Affairs Forum: Health Services and Latino Youth: Challenges, Collaborations, and the Social Safety Net

This panel will focus on local jurisdictions, including city, county, and state, consider variations across jurisdictions (e.g. Washington DC, Maryland and Virginia), and analyze ways that jurisdictions are adapting to the incentive structure created by national policy. Panelists will describe available youth and family health services and consider impacts of interrelated issues around immigration status. The core question will be how local jurisdictions promote access to health services for Latino youth.
