

# AUWCL COST OF ATTENDANCE SUMMER 2024

The Cost of Attendance (COA) is the maximum amount of financial aid permitted. Costs are associated with and limited to the period of enrollment.

Living expense refunds, if applicable, are available after all spring grades are posted and satisfactory academic progress is confirmed. Financial aid cannot disburse early to cover expenses.

Enrollment in a minimum of three credit hours is required to receive federal financial aid through an approved Direct PLUS Loan.

For the summer term, Direct PLUS loan recipients that request the maximum will receive an offset based on their actual loan fees incurred at disbursement.

For students attending summer classes (minimum of 3 credits) and approved for Federal Work-Study (FWS), the FWS award is included in the summer COA and reduces Direct PLUS loan eligibility by the amount of the FWS award. A separate FWS application is required.

1. Complete a 2024-2025 Free Application for Federal Student Aid (FAFSA).
2. Complete a 2024-2025 Direct PLUS Loan request for the May 2024 to August 2024 loan period at <https://studentaid.gov>.  
NOTE: For the summer term, Direct PLUS loan recipients that request the maximum will receive an offset based on their actual loan fees incurred at disbursement.

3. Once registration is finalized, submit the Application for Summer Assistance available on the AUWCL Financial Aid website - "Financial Aid Forms" page. Available on the first day of summer registration. **Submit after May 1, 2024**
